Workshop : Implementing SDGs in and by Europe:
What role for NGOs in the new partnership?

1. Background

In Europe as much as everywhere in the world, reaching the Sustainable Development Goals (SDGs) by 2030 will not be an easy task. To meet the challenge, governments insist on the need for all stakeholders to engage in the national implementation of these goals, in particular Non Governmental Organizations (NGOs).

Two years after the adoption of the SDGs, we observe that the definition of this new partnership is not clear yet, and that the mobilisation of NGOs differs widely across countries and sectors. A recent study among NGOs showed that the awareness of national SDG implementation plans and processes is particularly low in Europe, with 54% of respondents not being aware of their countries implementation plans for the 2030 Agenda and the SDGs (Together 2030, 2017).

In this closed, interactive workshop, actors from different European countries and sectors will interact in an informal setting in order to clarify expectations, exchange best practices and promote mutual learning. They will also discuss difficulties and barriers encountered in the mobilization of NGOs and identify concrete solutions to strengthen their participation and contribution to the implementation of the Agenda 2030 in and by Europe.

2. Format

The workshop will be interactive and discussion-based rather than presentation-based. All participants are expected to actively participate in the informal discussions and encouraged to share their experiences and expectations as regards the mobilization of NGOs around the SDGs at the national or EU level. If you want to prepare for the discussions, you may reflect on the questions here below :

How are NGOs mobilizing around the SDGs in your country? Who is mobilizing and why? Why are some NGOs not mobilizing?

How would you define the roles of NGOs in the new partnership for the SDGs?

What is needed to ensure meaningful and transparent multi-stakeholder partnerships for the implementation of SDGs?

Are you involved in a multi-stakeholder partnership for the implementation of the SDGs? What are the lessons learnt so far? What challenges do you encounter? What are the next steps?

Are you involved in an NGO coalition or platform that uses the SDGs for joint advocacy or accountability activities? What are the lessons learnt so far? What challenges do you encounter? What are the next steps?

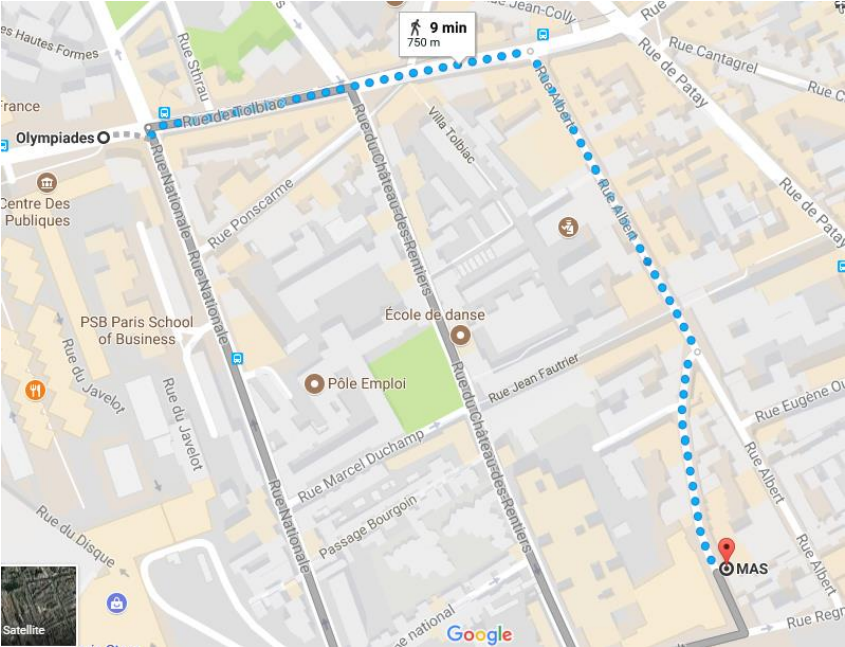
